Get Mic'd UVOS - Take 3 | Event Master Sponsorship Agreement

This Get Mic'd Event Master Sponsorship Agreement ("**Agreement**") is made on the Effective Date Below, between Get Mic'd, (Executive Producer) ("**Get Mic'd**") and the person (individual or legal entity) identified in the signature block below ("**Sponsor**").

RECITALS

- A. Get Mic'd organizes events from time to time to facilitate interactions between Get Mic'd community members (each an "Event").
- B. Sponsor from time to time may wish to sponsor a Get Mic'd Event by providing cash, goods, services or other value.

For valuable consideration, the receipt and sufficiency of which are acknowledged, Sponsor and Get Mic'd agree as follows:

AGREEMENT

1. SPONSORSHIP. Get Mic'd and Sponsor may from time to time enter into arrangements for Sponsor to provide cash, goods, services or other value in connection with an Get Mic'd Event. The parties agree that any such arrangements will be subject to the terms of this Agreement. The parties will execute a written agreement describing the sponsorship and any related activities and obligations of the parties in a signed document similar to the form of Sponsorship agreement attached to this Agreement as Exhibit A (the "**Sponsorship Agreement**").

2. MARKS. As used below, each party's respective names, logos, trademarks, trade names, domain names, and other identifying indicia shall be referred to as its "Marks."

- Sponsor may use the Get Mic'd Marks as needed and we encourage promotions
- Get Mic'd may use Sponsor's Marks only at or in connection with the Event and only as specifically authorized in a Sponsorship Agreement. Any such authorization shall be a royalty free, non-exclusive, non-transferable, non-sublicenseable, limited term license to use the Mark(s), subject to any restrictions stated in the Sponsorship Agreement. Get Mic'd agrees to comply with Sponsor's trademark usage policies and ongoing instructions and supervision with respect to its Marks communicated to Get Mic'd, including (i) the context in which the Marks are used; (ii) the substitution of a newer version of a Mark for a version previously authorized (where practicable); (iii) the size, color, and graphic quality of the display of the Marks; and (iv) all other matters within the reasonable discretion of Sponsor. Sponsor reserves all rights in its Marks, including any non-English version of such Marks. Get Mic'd's use of Sponsor's Marks shall inure to the benefit of Sponsor.

3. PAYMENTS. Invoices for Sponsorship amounts shall be due thirty (30) days from invoice date (or a date agreed upon by both parties). If Sponsor fails to pay any amount when due, Get Mic'd may charge interest on the overdue amount at the rate of 18% per annum. If any amount is more than thirty days past due, and Get Mic'd brings a legal action to collect the overdue amount, Sponsor shall be liable for Get Mic'd's reasonable costs of collection, including collection agency fees and reasonable attorney fees.

4. SPONSOR'S RIGHTS

4.1 *The Ultimate VO Survivor* reserves the right to refuse to use advertising or programming material, which may be deemed offensive, inappropriate or sexually explicit.

4.2 *The Ultimate VO Survivor* reserves the right to terminate a sponsorship contract with a Sponsor at any time should there be enough evidence that the Sponsor is involved in activities which are illegal, offensive, inappropriate or otherwise harmful to *The Ultimate VO Survivor* and its community.

4.3 *The Ultimate VO Survivor* reserves the right to terminate a sponsorship contract with a Sponsor should the Sponsor be unable to deliver the cash or in-kind sponsorship by the agreed upon date.

4.4 The Sponsor is responsible for ensuring that all advertising materials and logos for are submitted to *The Ultimate VO Survivor* in the appropriate format by the specified deadline. Failure to do so will result in loss of advertising and promotional opportunities.

4.5 The Sponsor must sign the sponsorship contract before "The Ultimate VO Survivor" delivers on sponsorship benefits.

4.6 The recipient agrees to provide a representative to the Sponsor, if they so wish, to report back and ensuring the terms of the agreement are fulfilled.

5. INDEMNIFICATION. If Get Mic'd or any of its respective employees, agents, or owners (collectively the "Get Mic'd Indemnitees") is faced with a legal claim by a third party arising out of the use of the Sponsor's Marks as permitted by this Agreement, Sponsor will pay the cost of defending the claim (including reasonable attorney fees) and any damages, award, fine, or other amount that is awarded against the Get Mic'd indemnitees as a result of the claim. This Section shall survive expiration or termination of this Agreement.

6. EXPIRATION AND TERMINATION. This Agreement will remain in effect until terminated by a party on written notice. Each Sponsorship shall remain in effect for the period stated in the Sponsorship. Either party may terminate this Agreement or a Sponsorship Agreement, without liability, if the other party violates the terms of this Agreement or a Sponsorship Agreement, and fails to cure such breach within five (5) days of the other party's written notice. Upon termination of this Agreement or a Sponsorship Agreement by Sponsor for Get Mic'd's breach, Get Mic'd will cease use of the Sponsor's Marks as promptly as commercially practicable; upon termination on any other grounds, Get Mic'd may continue to use the Marks as provided in the Sponsorship for the time period allowed in the Sponsorship.

7. NOTICE. Legal notices shall be given via electronic mail and confirmed via mail to the address for Rackspace below, and to Sponsor's address stated below the signature block. Notices are deemed received on the day transmitted via electronic mail, or if that day is not a business day, on the first business day following the day delivered.

8. OTHER. Neither party is the agent of the other, and neither party shall have any authority to make any promise, representation, or contract of any nature on behalf of the other party. **The laws of the Province of Ontario (exclusive of its choice of law principles) and, to the extent applicable, the laws of Canada, govern this Agreement. This Agreement shall not be governed by the United Nations Convention on the International Sale of Goods.** Exclusive venue for all disputes arising out of the Agreement shall be brought in the province or federal courts of Ontario, Canada, and we each agree not to bring an action in any other venue. **You waive all objections to this venue and agree not to dispute personal jurisdiction or venue in these courts.** This Agreement supersedes all prior oral and written understandings, representations, communications, and agreements between the parties and constitutes the final and entire agreement of the parties regarding the subject matter of this Agreement.

This Sponsorship is entered into between the parties signing below as of the date of last signature below, and is subject to Get Mic'd Event Sponsorship Agreement between the parties as dated below (the **"Agreement"**). Capitalized terms used in this Sponsorship and not otherwise defined herein shall have the meaning given in the Agreement.

TRADEMARK USE PERMISSIONS:

Get Mic'd may use the Sponsor's Marks in connection with the Event described above at the Event, and for a reasonable period of time preceding and following the Event (not to exceed 12 months) as follows:

Any Sponsor use of Get Mic'd Marks for promotional purposes is welcome

CONFIDENTIALITY:

The terms of this Sponsorship Agreement are confidential information of the parties and may not be disclosed to third parties without written permission from the other party, except as reasonably necessary to complete the sponsorship activities described in this Sponsorship.
